With due regard, I would like to submit that our Federation has received endorsement copy of representation from our member Shri Sonu, Nursing Orderly against transfer Office Order No. 200 of 2015 E-I (M) issued through File No. 111A-11/15/01/N.O./2014/E.I (M) dated 16-10-2015 (Copy enclosed).

In this regard, I have been made to believe that the transfer posting have been initiated without giving due consideration to transfer posting norms by not following principle of "First Come First Go".

Shri Sonu, Nursing Orderly has been transferred to ESI Hospital Okhla with out giving due consideration to following facts :

1. He has been selected for posting in ESI Hospital, Okhla with out considering the fact that many Nursing Orderlies in ESI Hospital, Rohini are working in same hospital from more then last 10 years and the principle of first come first go has been grossly ignored.
2. He has not given any option for posting in ESI Hospital, Okhla.
3. His residence is at Narela and the present place of posting i.e. ESI Hospital, Okhla is 65 kms away from his residence.

In view of above compelling facts, you are requested to kindly cancel the transfer of Mr. Sonu, Nursing Orderly of ESI Model Hospital, Rohini.
